Sub: Re-organisation of Customs Formations in Chennai Zone as per Notification No.82/2017 Cus (NT) dated 24.08.2017 as amended – Reg.

Reference is invited to the Public Notice No.01/2018 dated 11.01.2018 and Clarification to Public Notice No.01/2018 dated 11.01.2018 issued by the Commissioner of Customs (Preventive), Trichy regarding re-organisation of Customs Formations/ Customs Functions hitherto handled by GST & Central Excise Officers of Chennai Zone, consequent to the issue of Notification No.82/2017-Cus(NT) dated 24.08.2017 as amended by Notification No.03/2018-Cus(NT) dated 10.01.2018 issued by Central Board of Excise & Customs, New Delhi.

2. According to the above said Notifications and clarifications thereon, it has been clarified that the LUT/ Bond for the purpose of export of goods without payment of duty (i.e. IGST) has to be executed before the jurisdictional GST authorities only.

3. As regards, the transfer of records/ files handled in Commissionerate Headquarter and Divisions, officers may ensure that while transferring all the customs related records/ files, separate list of records which are time bound in nature and require immediate action may be prepared and the Section Heads may be briefed of the Time Bound nature.
