Assesseees are advised to pay the Central Excise duty and Service Tax well in advance of the due date i.e 31.03.2015 to avoid interest for delayed payment for the month /quarter ending March,2015.

In this regard it is informed that in case any Central Excise or Service Tax Assessee experiences difficulty in making e-payment, due to non availability of online payment option, they may contact the authorized banks in advance or the Regional Focal Point Branch (FPB) **well before 4.00 PM on 31.03.2015**



3. The Assesseees making e-payments on 31.03.2015(Tuesday) are advised to do so **before 5.00 PM** so as to facilitate realization of the amounts by evening on the same day i.e 31.03.2015 positively. [To be included in the revenue realization for the current financial year 2014-15]

Besides, in order to keep the assesseees informed about the latest changes in Law/Rules/Procedure/Rate of Duty /facilitative schemes and also to remind them about various deadlines like Last date for payment of taxes/duties and filing of returns, a **new SMS service** has been made operational through NIC's SMS facility. Hence assesseees are advised to include/update their mobile numbers (more than one number can also be included) in their Central Excise and Service Tax Registration details in ACES by making suitable amendments. Similarly assesseees can amend/update their email ids to receive regular information/alert emails.
