Sub : Central Excise – Reconstitution of Public Grievance Committee for Organised, SSI and Service Tax Sectors for Central Excise Commissionerate, Trichy for the year 2006 & 2007 - Regarding.

The Trade is hereby informed that Public Grievance Committee for the Organized, SSI and Service Tax Sectors has been constituted for the year 2006 & 2007 for the Central Excise Commissionerate, Trichy with immediate effect in the Office of the Commissioner of Central Excise, No.1, Williams Road, Cantonment, Trichy-1. A list of constituent members of Public Grievance Committee is enclosed.

2. The Commissioner of Central Excise, Trichy will be the ex-officio Chairman of the Committee. The Additional Commissioner (P&V) of the Central Excise Commissionerate, Trichy will be functioning as the Member / Grievance Redressal officer.

3. Grievances on the matters relating to Central Excise and Service Tax in respect of Trichy Central Excise Commissionerate may either be sent in writing or represented to the Committee in person at the above address.

4.1 Functions of the Committee:

The function of the committee is exclusively to deal with the citizen's grievances on regular basis and will not deal with policy issues relating to taxation. This committee will listen to grievances made to it orally and examine written complaints/grievances and action initiated for redressal. Decision on the grievances received in any meeting will be intimated in the next meeting.

4.2. Life period of the committee:

The life period of the committee is normally 2 years commencing from the date of issue of this notice. Any member of the committee who is absent from 3 consecutive meetings, without adequate reasons, will be deemed to have withdrawn from the committee and his place will be filled by fresh nomination.

4.3 Meeting of the Committee:

The Committee will meet once in a quarter. Meeting will be held at Hqrs. Office or some other place in the jurisdiction of Trichy Central Excise Commissionerate as may be decided by the Chairman, if occasions warrants.

4.4 Travelling and daily allowance:

Travelling and daily allowance will be regulated according to the orders in force.

5. As the success of the Committee depends upon the attendance of the member and the matters discussed therein all the members may please ensure their presence in the meeting without fail and the Public are requested to approach the Committee if they have any grievance.
