Sub: Authorisation of Oriental Bank of Commerce for collection of Central Excise
duties and Service Tax through e-payment-Reg.

It has been decided with the approval of Controller General of Accounts to authorize Oriental Bank of Commerce for collection of Central Excise duties and Service Tax through e-Payment mode.

Oriental Bank of Commerce will strictly follow the processes and procedures as detailed in the EASer Accounting Procedure and instructions issued by RBI from time to time in this regard . In addition, the following points notwithstanding whether these are contained in the EASer accounting Procedure or separate instructions have been issued in this regard may also be followed :-

1. The bank will be allowed to accept e-payments of Central Excise duties and Service Tax for all Central Excise, Service Tax and LTU Commissionerates without the restriction of Commissionerate-wise authorization.

2. The **Mylapore Branch of Oriental Bank of Commerce(BSR Code No.0361086), No.63 Radhakrishnan Salai , Mylapore, Chennai-600004** will act as the Receiving and the Focal Point Branch for collection of e-Receipts of Central Excise duties in respect of all Commissionerates.
