Attention of all officers and staff of this Commissionerate are invited to (i) Board's letter F.No.A.28011/15/14-S0 (Per/EC)-Ad.II dated 26.12.2014 enclosing therewith DOPT's O.M.No. 407/12/2014-AVD-IV(B) dated 25.12.2014; (ii) Board's letter F.No.A.28011/15/14-S0 (Per/EC)-Ad.II dated 29.12.2014 enclosing therewith a copy of the Gazette Notification No.GSR-918(E) dated 26.12.2014 on the subject matter; (iii) Notification No/dated 14th July, 2014 issued by the Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training) which are hosted in the CBEC's web-site <http://www.cbec.gov.in> under the caption 'Submission of declaration of assets and liabilities by the public servants'.

2. The Government has since amended the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the limits for Exemption of Assets in Filing Returns) Rules, 2014 under the Lokpal and Lokayuktas Act, 2013 vide Notification NO.G.S.R. 918(E) dated 26<sup>th</sup> December 2014, in terms of which, the last date of revised returns of assets and liabilities by public servants has been extended to 30 April 2015. The Notification is available on the website of the DOPT. Further, the Govt. have also modified Form No. I and Form No. IV for filing of the returns. The revised formats are attached herewith. Accordingly, all the Officers and staff shall be required to file the revised declarations, information as on the 1.8.2014 by 30.4.2015.

3. It may be noted that the definition of public servant covers all Central Government servants (Group A, B, and C). Therefore, all Central Government servants are required to file the declaration. This is an important difference from the CCS (Conduct) Rules 1964 and all concerned are required to note this point.

4. The extended date and the modified formats for filing of the returns may be brought to the notice of all the Officers and staff under your charge. Accordingly, all concerned are advised to go through the instructions contained in the CBEC's web-site <http://www.cbec.gov.in> under the caption 'Submission of declaration of assets and liabilities by the public servants' carefully and to comply with the instructions.

5. The earlier instructions issued by this office vide letter of even number dated 01.09.2014 may be treated as modified to the extent stated above.

**Note 1:** This return shall contain particulars of all assets and liabilities of the public servant either in his/her own name or in the name of any other person. The return should include details in respect of assets/liabilities of spouse and dependent children as provided in Section 44(2) of the Lokpal and Lokayuktas Act, 2013.

{Section 44(2): A public servant shall, within a period of thirty days from the date on which he makes and subscribes an oath or affirmation to enter upon his office, furnish to the competent authority the information relating to –

- (a) The assets of which he, his spouse and his dependent children are, jointly or severally, owners or beneficiaries;
- (b) His liabilities and that of his spouse and his dependent children.)

**Note 2:** If a public servant is a member of Hindu Undivided Family with co-parcenary rights in the properties of the family either as a 'Karta' or as a member, he should indicate in the return in Form No.III the value of his share in such property and where it is not possible to indicate the exact value of such share, its approximate value. Suitable explanatory notes may be added wherever necessary.

**Note 3:** "dependent children" means sons and daughters who have no separate means of earning and are wholly dependent on the public servant for their livelihood. (Explanation below Section 44(3) of Lokpal and Lokayuktas Act, 2013
