As per provisions of Recruitment Rules for Sepoy, the following Safaiwalas are absorbed against the post of Sepoy with effect from the date of their joining.

2. On absorption as Sepoys their pay shall be fixed in the scale of –1S as per 6th Pay Commission with corresponding Grade Pay of Rs.1600/-. As it is only absorption there will not be any fixation of pay and allowances now.
